

Corporation Agreement is made on the 15/ 2 / 2023

**Part A AGREEMENT PARTIES :**

- (1) Oman Air Sports Committee (**OASC**)–Sultanate of Oman - Muscat- ruwi Box code: 100
- (2) Association of Paragliding Pilots and Instructors (**APPI**), MSA - 41A route des Jeunes 1227 Carouge SWITZERLAND

(1) and (2) Hereafter referred as The **Parties**.

Whereas Association of Paragliding Pilots and Instructors (**APPI**) is an independent organization provid Paragliding Paramotor and ParaTrike Pilots and Instructors an International Education System, guaranteeing a consistent quality of education all around the world.

Where are Oman Air Sports Committee (**OASC**) is a committee formed by Ministerial Decision ref. no (2021/131) dated 30 September 2021.

**Now, therefore, the parties hereby agree as follows:**

**Part B SCOPE OF AGREEMENT:**

- a) Both parties shall act on this agreement in a manner that does not contravene the laws and regulations in force in the Sultanate of Oman.
- b) Both parties agree to keep, perform and fulfill the promise and conditions set out in this agreement:
- c) APPI agrees to share with OASC free of charge all updated educational resources on continuing basis
- d) APPI agrees to provide OASC registered pilots an access to its online exams system in order to have OASC pilots take theoretical exams. In order to achieve this, OASC pilots will have to become APPI members.
- e) APPI logbook as well as the exam questions will be available in Arabic in the APPI system
- f) Theoretical and practical exams will be conducted by APPI certified instructors.
- g) Certifications will be issued only upon reaching APPI published standards.
- h) OASC agrees to officially recognize APPI solo, Tandem, Instructors and Master certifications.
- i) APPI instructors with a permit granted by the Oman CAA will be allowed to teach in Oman.
- j) OASC understands that a resident of Oman might learn paragliding in any APPI school worldwide and being granted APPI certifications accordingly.
- k) APPI instructors with a permit granted by **the Authority** of Oman will be allowed to teach in Oman.

- l) Educational actions (pro-workshops) will be conducted in order to identify current Omani instructors are eligible to hold the APPI instructor rating.
- m) APPI license for Omani citizen and resident will carry together the OASC and the APPI logo
- n) Due to the very specific situation, in order to fly in Oman an APPI member will have to learn about the specifics of Oman airspace use and site specifics and procedures. These procedures are promulgated by **the Authority** and OASC jointly. They might need to complete an Oman Air Legislation Exam and contact any OASC +APPI pro-rated pilot for permitted sites briefing.
- o) APPI ensures to harmonize with World Air Sports Federation (AFI) to facilitate hosting related sport events for favor of OASC in Oman within the agreed scope.
- p) If there is any disciplinary issue with an APPI member who is an Oman resident, the APPI disciplinary committee will inform the OASC.
- q) If there is any disciplinary issue with an APPI member flying in Oman the OASC will inform APPI disciplinary committee which will investigate and take the appropriate actions.

#### **Part C TERMS:**

- a) This Agreement has an initial term of (3) years from the Effective Date (the "Initial Term") with an auto-renewal option unless otherwise is separately stated by APPI and OASC or bilaterally.
- b) If necessary to continue with product testing, this Corporation Agreement may be renewed upon mutual written Corporation Agreement between the parties (the "Renewed Corporation Agreement"). The Renewed Corporation Agreement shall substantially have the same terms and provisions as this Corporation Agreement, unless the parties mutually agree otherwise.

#### **AMENDMENT**

This Agreement may not be amended, altered or modified except by a subsequent written document signed by all Parties.

#### **TERMINATION**

This Agreement shall become effective upon signing by the Parties and ratified by the unless terminated by APPI and OASC bilaterally.

## DISPUTE SETTLEMENT

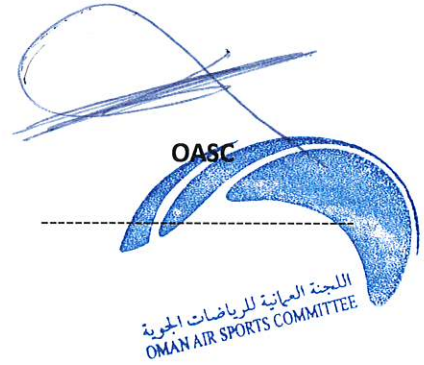
